Preference in awarding the scholarships will be given to chapter members who have demonstrated progress toward meeting designation requirements as well as supporting the Chapter. Any member is encouraged to apply.

The scholarships will consist of up to \$500 towards tuition for courses presented by the Greater Oregon Chapter of the Appraisal Institute that meet designation requirements. Awards must be used within one year of award. The scholarships have no direct cash value.

The Greater Oregon Chapter of the Appraisal Institute reserves the sole right to choose the award recipient(s). Award decisions cannot be appealed to national Appraisal Institute representatives. The Greater Oregon Chapter also reserves the right to withhold recommendations for scholarships in any given year and the right to request additional information from the applicant. All application materials will be considered confidential and will not be returned to the applicant. The chapter will award up to two scholarships per calendar year. The first scholarship application deadline is June 1 and will be announced by June 30. The second scholarship deadline is December 1 and will be announced by December 31.
